8th ANNUAL RIB GIVEAWAY
OFFICIAL RULES



NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

1. Eligibility: The Shane's Rib Shack 8th Annual Rib Giveaway (the "Giveaway") is open only to legal residents of the 50 United States and Washington, D.C. who are 13 years of age, as of April 29, 2017. Employees of Shane's Rib Shack ("Sponsor") and its affiliates, subsidiaries, advertising and promotion agencies and suppliers that are involved in this Giveaway (collectively, the "Sponsor Parties"), and each of their immediate family members (mother, father, sister, brother, husband, wife, daughter, son, step-father, step-mother, step-daughter, step-son, step-brother, step-sister, half-brother, and half-sister) and/or those living in the same household of each are not eligible to participate or win any prize. Void where prohibited by law. **The Grand Prize drawing is limited to persons age 18 and older. Residents of Florida and New York are not eligible to enter for Grand Prize Drawing. 2. How to Participate: Arrive at a participating Shane's Rib Shack Restaurant ("Restaurant") on April 29, 2017 (the "Giveaway Period"). **Giveaway line begins at 8:00 AM.** The first 101 eligible persons ("Participants") to arrive at the Restaurant during the Giveaway Period will receive a Giveaway Prize (as described below) subject to compliance with these Official Rules. The odds of receiving a Giveaway Prize depend on the number of eligible persons who participate in the Giveaway at each Restaurant. Giveaway Prize winners will be determined on a first come, first serve basis. See Restaurant for additional rules and restrictions. 3. Giveaway Rules. Participants may be required to remain in a designated area and/or queue while at the Restaurant. Exceptions are made for short bathroom breaks and/or to comply with any applicable legal requirement, or otherwise in the sole discretion of Sponsor. Participants may be required to wear a t-shirt or similar marker in Sponsor's discretion. No illegal drugs or alcohol are permitted at the Restaurant at any time. Anyone under the influence of alcohol or illegal drugs will be disqualified from the Giveaway and will be required to leave the Restaurant immediately. Sponsor may restrict or prohibit the possession of certain other items at any Restaurant in its sole discretion.

4. Giveaway Prize: Subject to complying with these Official Rules, the eligible Participants will receive the following: one ½ rack of Baby Back Ribs, one special edition Rib Giveaway t-shirt, and one 20 oz. beverage (the "Prize"). Limit one (1) Prize per person. Approximate retail value of the Prize is \$21.70. Prizes may not be sold, offered for sale, assigned, transferred, offered for transfer, photocopied, duplicated, or redeemed or exchanged for cash, except by Sponsor, in its sole and absolute discretion, which reserves the right to substitute Prizes with a prize of comparable or greater value if underlying food products become unavailable for any reason. With regard to the coupon portion of any Prize, please note the following: you must present and surrender the coupon to get the offer; coupons are void where restricted, prohibited or taxed; coupons not transferable, including via electronic means; no copies (electronic or print), facsimiles or photographs accepted; coupons are void if reproduced, copied, altered, transferred, purchased or sold; internet distribution of coupons is strictly prohibited; coupons may not be combined with any other promotion or offer; no cash refunds are given for coupons; coupons may not be accepted at some Shane's Rib Shack restaurants; any other use of coupons constitutes fraud; and coupon redemption is subject to review and verification. Each Participant is solely responsible for any applicable taxes and unspecified expenses associated with a Prize. In the event that the Giveaway is cancelled or preempted for any reason, including weather, no rain checks, exchanges, substitution or cash replacement value of a Prize will be provided. Residents of Florida and New York are not eligible to enter for Grand Prize Drawing.

5. Grand Prize Drawing. Each Participant (age 18 and older and excluding residents of Florida & New York) will also be entered into the Grand Prize drawing for the chance to win a cash prize equal to \$2,500 ("Grand Prize"). Odds of winning a Grand

Prize are 5:6363. To be entered into the Grand Prize Drawing, each eligible participant will submit his/her first name, last name, and phone number into the sanctioned drawing entry device provided at the Shane's Rib Shack Restaurant. Exactly five (5) Grand Prizes will be awarded by random drawing on or about April 29th, 2017, from among all eligible entries received. The drawing will be conducted by Sponsor's designated agent, PlumReward, LLC. The Grand Prize winner will be notified by telephone, or as determined by Sponsor. It is the sole responsibility of Participant to notify Sponsor if his/her contact information changes. Grand Prize winner may be required to sign an affidavit of eligibility and release of publicity/liability ("**Affidavit**") (where legal) within two (2) days. If a potential winner cannot be contacted via the telephone number provided within two (2) days (or other time period noted by Sponsor) of the first attempt to contact him/her, or if he/she fails to return the signed Affidavit within two (2) days (or other time period noted by Sponsor), or if the potential Grand Prize winner is deemed ineligible for any other reason in Sponsor's sole discretion, the potential Grand Prize winner will be disqualified and an alternate Grand Prize winner will be selected in his/her place by random drawing amongst all remaining eligible entries received. Winner is solely responsible for all applicable taxes and unspecified expenses associated with a Grand Prize.

6. Publicity: Except where and as may be prohibited by law, participation in the Giveaway and acceptance of a prize constitutes express permission by Sponsor, and those acting pursuant to the authority of Sponsor, to use such Participant's name, photograph, image, likeness, voice, opinions, hometown, and/or state for advertising, trade, promotion, and publicity purposes in all forms of media now known or hereafter discovered or devised, worldwide in perpetuity, without further notice, review or approval, or compensation. If you do not agree to these terms, you should not participate in the Giveaway.

7. General Conditions: All federal, state, and local laws and regulations apply. Neither Sponsor nor any other Sponsor Party is responsible for lost, late, incomplete, stolen, misdirected, illegible, or incomplete entries, or for any incorrect or inaccurate information, whether caused by Sponsor Parties, tampering, or by any of the equipment or programming associated with or utilized in the Giveaway, and neither Sponsor nor any Sponsor Party assumes responsibility for any error, omission, defect, theft, destruction, or unauthorized access to the materials related to the Giveaway. Sponsor reserves the right, in its sole discretion, to disqualify any Participant found to be tampering with the entry process or the operation of the Giveaway, to be acting in violation of these Official Rules, or to be acting illegally or in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten, or harass any other person. In such event(s), Sponsor reserves the right (in addition to disqualification of such Participant) to seek damages from any such Participant to the fullest extent permitted by law. If, for any reason, the Giveaway is not capable of running as planned by reason of, but not limited to, tampering, unauthorized intervention, actions by persons, weather, acts of God, fraud, or any other causes which, Sponsor, in its sole opinion, deems could corrupt or affect the administration, safety, security, fairness, integrity, or proper conduct of the Giveaway, or the Giveaway is otherwise not capable of running as planned, Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend the Giveaway. If the Giveaway or any portion of the Giveaway is terminated before the end of the Giveaway Period, Sponsor may, in its sole discretion, elect to award prizes to all Participants. In the event that a prize cannot be awarded for any reason, or if a Participant is not capable of redeeming the prize for any reason, Sponsor shall not be obligated to award any such prize, and Sponsor reserves the right, in its sole discretion, whether or not to substitute a prize (or portion of prize) with a prize of comparable or greater value or cash value. If, for any reason, more than the stated number of prizes are available and/or claimed, Sponsor reserves the right, in its sole discretion, to award more than the stated number of prizes. A person is not a Participant until he or she has fully complied with these Official Rules. A prize is not exchangeable for cash, merchandise, or services except as stated on the coupon, as applicable. No groups, clubs, newsletters, or organizations may reproduce or distribute any portion of these Official Rules to their members, and anyone who participates in the Giveaway through means not permitted by these Official Rules is subject to disqualification.

Release: By participating in this Giveaway, the Participant agrees to release, indemnify, and hold harmless the Sponsor Parties from any and all liability for any injuries, loss, harm, damage, cost, or expense of any kind to any person(s), including, without limitation, property damage, personal injury, and/or death, arising in whole or in part, directly or indirectly, from acceptance, possession, use, and/or misuse of a Prize or Grand Prize, participation in this Giveaway or any Giveaway-related activity, being present at the Restaurant for the Giveaway, and for any claims based on publicity rights, defamation, or invasion of privacy.

9. Limitation of Liability: Except where prohibited, the Participants agree that: (1) any and all disputes, claims, and causes of action arising out of or in connection with this Giveaway, or any prize awarded, or the determination of a winner, shall be resolved individually, without resort to any form of class action; (2) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and (3) under no circumstances will the Participant be permitted to obtain awards for, and the Participant hereby waives any and all rights to claim punitive, incidental, consequential, and any other damages, other than for actual out-of-pocket expenses, and Participant hereby waives any and all rights to have damages multiplied or otherwise increased.

Agreement to Official Rules: By participating in the Giveaway, each Participant fully and unconditionally agrees to and accepts these Official Rules and the decisions of Sponsor (including but not limited to Sponsor's employee(s) handling prize awards), which are final and binding in all matters relating to the Giveaway. By participating in the Giveaway, each Participant waives any right to claim ambiguity in these Official Rules. The failure or delay by Sponsor in enforcing any particular clause,

provision, or aspect of these Official Rules shall not impact the validity, enforceability, or effect of such clause, provision or aspect, or any other clause, provision, or aspect of these Official Rules.

11. Choice of Law: All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of the Participant and/or Sponsor in connection with the Giveaway, shall be governed by, and construed in accordance with, the laws of the State of Georgia without regard to conflicts of law/choice of law doctrine of Georgia or any other jurisdiction, and all proceedings shall exclusively take place in the United States District Court for the Northern District of Georgia, or Georgia State Court located in Atlanta, Georgia. The Participant agrees to the jurisdiction of such courts and waive any right to change of venue or any like right.
